5 Year Agreement Summary between Operating Engineers Local 513 and the Bituminous Paving contractors performing work on State Highways and Large Municipal Roads

- Contract Length: 5 years – June 1st, 2023 through May 31st, 2028
- Closed Book Agreement: - no changes
- Wage Increases: Wage Increases to mirror SITE Improvement Association/Local 513 Agreement covering Commercial/Heavy/Highway work
- Effective Date of Contractual Increases:

2023 – Monday, June 5th, \$3.25 – Wages and Fringes to be Allocated by Union
2024 – Monday, June 3rd, \$3.00 – Wages and Fringes to be Allocated by Union
2025 – Monday, June 2nd, \$2.75 - Wages and Fringes to be Allocated by Union
2026 – Monday, June 1st, \$2.70 - Wages and Fringes to be Allocated by Union
2027 – Monday, June 7th, \$2.70 - Wages and Fringes to be Allocated by Union

Any employees performing work under old work old pay provision will be afforded increases no later than Monday, October 2nd, 2023 as indicated in the Letter of Understanding between the Bituminous Paving Contractors and Local 513.
